

Owners Certificate of Dedication and Restrictive Covenants

Dean Katsaros and the Champaign Park District being the legal owners and subdividers of the premises situated in Champaign County, Illinois, described as follows:

All of Lots 700, 718 and 719 of Robeson Meadows Subdivision No. 7 as recorded in Plat Book BB, Page 168, Document #92R 13167 in the Champaign County Recorders Office.

and having previously decided to subdivide and lay out the same into lots, and having previously dedicated to the public the easements and rights of way for public use within said subdivision, designated as Robeson Meadows Subdivision No. 7 on the plat prepared by Thomas B. Jordan, Illinois Registered Land Surveyor No. 2014, dated May 5, 1992, does hereby designate this as the Replat of Lots 700, 718 and 719 of Robeson Meadows Subdivision No. 7, City of Champaign, Champaign County, Illinois, and designates this as it's Owners Certificate and Restrictive Covenants. Conveyances of the lots situated in the replatted area shall without repeating the same be deemed to include the following restrictions which shall constitute covenants running with the land and shall be binding upon the grantees named in the various conveyances of lots situated in the replat, to the end that the owners of lots in the replatted area shall be assured of a controlled program of building and development, and of land usage on the replatted lots and adjoining property, which restrictions are as follows:

- 1) That all covenants approved in the Robeson Meadows Subdivision No. 7 are hereby reaffirmed.
- 2) That the additional covenant be attached as Exhibit "A" included with the previously mentioned covenants running with the land.

EXHIBIT "A"

COVENANT RUNNING WITH THE LAND

THIS Covenant made this 6 day of TAvarage, 1994 by	
DEAN KATSAROS residing at 2305 FIRSTHORN Chapty	IL.
Champaign, in Champaign County, Illinois (hereafter "GRANTOR").	

WITNESSETH:

WHEREAS, GRANTOR constructed a driveway and retaining wall and has installed landscaping along the north side of Lot 719 and the adjacent side of Lot 700 of Robeson Meadows Subdivision No. 7 (hereafter "Lot 700" and "Lot 719", respectively); and

WHEREAS, at the time the driveway and retaining wall were constructed on the south 12.5 feet of the part of Lot 700 adjacent to the north side of Lot 719, it was owned by the Champaign Park District, not GRANTOR, and was constructed without permission of the Park District or other persons with an interest in the easements on the property; and

WHEREAS, GRANTOR subsequently traded property with the owners of Lot 700 to allow all improvements referenced above to be located on the replatted Lot 719; and

WHEREAS, a storm sewer originally constructed on Lot 700 in an easement is now located under the driveway and retaining wall and landscaping referenced above; and

WHEREAS, the storm sewer is now located on Lot 719 as replatted and still located in a public utility easement; and

NOW, THEREFORE, in consideration of the settlement of disputes between GRANTOR and the City of Champaign, owner of the storm sewer referenced above, GRANTOR covenants and agrees as follows:

 GRANTOR agrees that should the City find it necessary or appropriate to perform any work on the storm sewer located on Lot 719 as replatted, originally located on Lot 700, GRANTOR and GRANTOR's successors in interests to said lot shall reimburse the City for all costs the City incurs in removing or extra costs incurred by the City in avoiding removing the driveway pavement, retaining wall, landscaping and any other obstruction to the easement installed by the lot owner. Replacement of such items shall be the responsibility of lot owner. Owner shall pay the City such costs of removal within thirty (30) days of the City sending a bill to GRANTOR for the same. The City shall be entitled to attorney's fees and court costs, including but not limited to all reasonable litigation expenses, it may incur in enforcing this Covenant.

2. This Covenant shall run with the land and is intended to bind all subsequent owners. This Covenant is enforceable by the City of Champaign, Illinois. A waiver by the City of its rights at any time shall not affect its right to enforce this Covenant at any other time.
